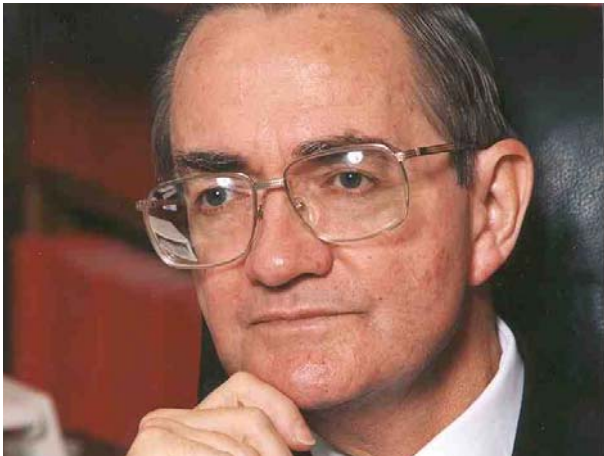

Hon Kevin Lindgren AM QC

Kevin Lindgren was a Judge of the Federal Court of Australia from 1994 to 2010. Prior to his appointment to the Bench, Dr Lindgren was successively a solicitor, academic, barrister and Queen's Counsel at the Sydney Bar. **11.30am Disorgement of profits as a common remedy for breach of contract**

Justice James Edelman

Justice Edelman was appointed to the Supreme Court of WA in 2011. Prior to his appointment, he took up a teaching position at Keble College, Oxford University, in 2005, and was appointed Professor of the Law of Obligations at Oxford in 2008. At Oxford he taught the subjects of restitution, commercial remedies, trusts, torts, contract and Roman law.

Professor Ho joined the Faculty of Law at Hong Kong University in 1992. Her book, *Trust Law in China* (2003), is so far the only comprehensive critique of Chinese trust law in English legal literature. While pursuing her research interests in trust and equity, restitution and comparative trust, she has provided advice to both the central and HKSAR governments in China in relation to the enactment and reform of trust legislation.
